**End notes:**

It is preferred that people who will be working with children attend a training seminar, rather than receive the training online. The seminars allow sharing of experiences and important conversations that are not possible with online training.

The following modules are required for Safeguarding God’s Children training: Meet Sam, It Happened to Me, Keeping Your Church Safe, and Policies- Episcopal Diocese of Maryland.

It is also recommended that other modules be completed according the type of ministry. For example: modules on camps for persons engaged in camp ministry, or bullying for after school programs and the like.
